**Calculation of the indemnity.** You are entitled to a reimbursement equivalent to 81.5297% of your losses related to the purchase and sale of shares of Capital Hubble Inc. or BigKnowledge Enterprises Inc. covered by the class action.

**Documentation to be transmitted.** You must provide documentation showing the **purchase price, number AND purchase date** of your BigKnowledge or Hubble shares. A document showing only the number of shares you own will not be considered sufficient. If you sold your shares, you will also need to demonstrate the sale price of the shares.

Your compensation will be paid by check sent by mail. You must therefore notify us of any change of address.
